COVERED PARTS*

01. Engine (Gasoline or Diesel): Engine block and internal parts listed as follows: crankshaft and bearings, balancers, pistons, shafts, connecting rods and bearings, camshafts and bearings, pinion, cylinder head, valves, valve spring guides, valve seats, rocker shaft(s) and rocker arms, rocker rods and tappets, oil pump, camshaft cap, front cover, hydraulic tappets, valve covers, vibration damper, sprockets and tensioners. All seals **(excluding head gaskets)** and filters are covered **only in cases of major breakdown.**

02. Automatic transmission: Housing, oil pump, oil pump rings, valve housings (valve body), torque converters, vacuum modulators, regulators, main shaft, clutches, belts, drums, gear sets, internal bearings, forks, sun gear, and synchronizer. All seals and filters are covered **only in cases of major breakdown. The flywheel is not covered by the warranty contract.**

03. Manual transmission: Housing, main shaft, gear sets, chain, sprockets, internal bearings, pads, and seals. All seals and filters are covered **only in cases of major breakdown. The following items are not covered by this warranty contract: clutch pack, flywheel, and flywheel resurfacing.**

04. Front and rear differentials: Housings and all internal parts, front and rear axles shafts **(not covered if protective boot is cracked)**, universal joints, crowns and pinions, pinion bearings, positraction unit, satellites, forks, drive shaft, support bearings, transfer case mount, self-locking clutch assembly. All seals, filters and rings are covered **only in cases of major breakdown.**

05. Front wheel drive: Casing and all internal parts, sprockets, chains, internal bearings, and gear sets.

06. 4X4 Transfer case: The 4x4 wheel drive option must have been declared at warranty contract signing to benefit from coverage. Housing and all lubricated internal parts, gear sets, drive chains, sprockets, internal bearings and bushings, main shafts, and transfer case mount. All seals, filters, and bushings are covered **only in cases of major breakdown.**

07. Turbocompressor (factory-installed by the manufacturer only): In order to benefit from coverage, the turbocharger option **must have been declared** at warranty contract signing. The parts covered are the turbocharger housing **(if damaged from the inside)**, internal mechanical parts, bypass valves (wastegate), intercooler, and relief valve actuator.

08. Surpercharger (factory-installed by manufacturer only): In order to benefit from coverage, the supercharger option **must have been declared** at warranty contract signing. The parts covered are the supercharger housing, internal mechanical parts, wastegate, and intercooler.

09. Steering: Housing and all internal parts, rack and pinion **(not covered if the protective boot is cracked)**, power steering pump, pulley, main, and intermediate shaft.

10. Towing: A towing allowance not exceeding seventy-five dollars (\$75) CAD (including taxes) per claim when the vehicle breakdown is caused by a failure. Said repair must be **expressly covered** by the warranty contract. It is the consumer's responsibility to provide Garantie Track Inc. with a copy of the towing invoice upon request.

11. Seals and rings: All seals **(excluding cylinder head gaskets in the event of overheating or deterioration)** and rings are covered **only in cases of major breakdown.**

12. Powertrain Plus: Intake manifold, exhaust manifold, vacuum pump, high-pressure pump, injection pump, fuel pump, water pump, camshaft sensor, crankshaft sensor, steering column, toothed sector axle and main and intermediate steering, engine and transmission oil pan **(excluding corrosion)**. Hub bearing assembly (4x4), and transfer case actuator are covered **only cases of major breakdown.**

13. Brake system: Master cylinder, brake booster, wheel cylinders, brake caliper **(excluding leak from the protective seal)**, pressure accumulator, brake compensator, wheel bearing, and hydraulic pump.

14. Electrical accessories: Cruise control switch, door lock activator (door latch), alternator, voltage regulator, starter, starter solenoid, turn signal and stop light switches, electric power window switches, light switches, power seat adjustment switch, heated seat switch, interior door lock switches **(excluding exterior keyless handle)**, front and rear wiper switches, rear defroster switch, sunroof switch, sunroof motor glass **(sunroof glass only, excluding sunshade motor and linkage)**, convertible roof motor, heater fan switch, power window delay module, electric window motor, front and rear wiper motor **(excluding linkage)**, electric seat adjustment switch (gear excluded), and front and rear windscreen washer pump.

15. Air conditioning system (factory-installed original parts only): Compressor, condenser (excluding damage caused by impact), accumulator, compressor clutch, pulley, high- and low-pressure switches, blower motor, and expansion valve. **The following items are not covered under the warranty contract: gas analysis, freon, oil, dye, filters and freon recover or refilling.**

16. Commercial vehicle: All makes and models of vehicles and trucks (maximum 2 tons) under a company name, business, trade name, and F plate. However, **vehicles such as police vehicle, ambulance, snow removal and towing vehicle, mobile canteen, off-road vehicle, driving school vehicle, public transport vehicle, delivery vehicle, and short-term leases, are not eligible for the Garantie Track Inc. warranty.**

REPRESENT PARTS INCLUDED

*Included parts are subject to change without notice and according to the warranty contract selected. Subject to the warranty contract's terms, conditions, and limitations. Other warranty contracts may be available. Please refer to your automobile dealer for full details. **In the event of any discrepancy between this brochure and the warranty contract, the warranty contract shall prevail.**

17. Vehicle rental: A vehicle rental allowance not exceeding fifty dollars (\$50) CAD (including taxes) per day up to a maximum of five (5) days and two hundred and fifty dollars (\$250) CAD (including taxes) per warranty contract is provided when the vehicle is repaired by a duly authorized centre and the vehicle is out of service due to the breakdown for more than forty-eight (48) hours after receiving approval by Garantie Track Inc. **(excluding Saturday and Sunday, as well as statutory holidays).** The repair must be expressly covered by the warranty contract for the rental allowance to apply. The deductible does not apply to the rental allowance. It is the consumer's responsibility to provide Garantie Track Inc. with a copy of the rental invoice upon request.

18. Lodging: A lodging allowance will be provided, for a hotel or motel located more than 250 km from the consumer's place of residence, not exceeding one hundred and twenty-five dollars (\$125) CAD (including taxes) per day for a maximum of five (5) days or six hundred and twenty-five dollars (\$625) CAD (including taxes) per warranty contract. To be eligible for this allowance, the vehicle must be out of service due to the breakdown for more than forty-eight (48) hours after receiving approval from Garantie Track Inc. **(excluding Saturday and Sunday, as well as statutory holidays).** The repair must be expressly covered by this warranty contract for the lodging allowance to apply. The deductible does not apply to the lodging allowance.

19. Fuel supply and ignition system: Injectors and injection pump, injection distribution, vacuum pump, thermal probes, induction coil, pressure regulator, and the following sensors: detonation, throttle body, air density (MAP sensor), and accelerator position.

20. Cooling system: Hydraulic fan clutch, radiator fan motor, engine, and transmission oil cooler (only if it is a part installed by the manufacturer or an original part), radiator and heater radiator unless damage **is caused by corrosion or impact.**

21. Front and rear suspension: Lower and upper transverse swinging arm and bushing, tie rods, deflection arms, suspension arms and bushings, ball joints and spindle bearings excluding shock absorbers.

22. Plus package: Engine and transmission mounts **in the event of major breakdown only and excluding corrosion**, poly-v-belt tensioner, anti-lock braking system (ABS) **(hydraulic unit only)**, speed sensors (ABS), and traction control system (ESP).

23. Hybrid system: Voltage control module, voltage temperature switch, inverter and/or converter. Batteries and auxiliary batteries are excluded from the warranty contract.

24. * Additional option - Multimedia package (factory-installed original parts only): GPS navigation system including console panel, touch screen, camera, information centre and

reverse sonar, forward sonar probe, collision warning probe, parking probe **(excluding paint)**, blind spot probe, adaptive cruise control, keyless entry module system **(excluding paint on the handle)**, Bluetooth hands-free phone control, microphone, control by voice recognition, DVD/Blu-ray player, entertainment system including screens in rear headrests, CD player and changer, updating and programming the GPS navigation system **(if system assembly is required and authorized for replacement).**

25. * Additional option - Diagnostic refund: If this option is selected and paid for, Garantie Track Inc. will reimburse a maximum of one hour (1 hr) of diagnostic time if the component is covered by warranty.

26. * Additional option - Oil filters, oil, and wheel alignment: Garantie Track Inc. will cover these items, if this option is selected and paid for, **if the part is covered** by the warranty contract and **only in cases of a major breakdown.**

27. * Additional option - Unlimited mileage: If this option is selected and paid for, there is no mileage limit during the term of this warranty contract.

28. * Additional option - Deductible at \$0: If this option is selected and paid for, the consumer will pay no deductible.

29. * Additional option - Taxi and delivery vehicle (people, meals, food, and packages): If this option is selected and paid for, Garantie Track Inc. will cover repairs to this type of vehicle.

30. * Additional option - Premium refund: If this option is selected and paid for, Garantie Track Inc. will refund the initial pre-tax premium, minus the purchase price of the option, up to a maximum of three thousand dollars (\$3,000) CAD. **At the end of the term of the warranty contract or financing contract, the consumer is eligible for a refund of the premium if the conditions listed below are met:**

- The eligible refund will not exceed the amount, before taxes, paid for the warranty contract indicated on the vehicle sale or lease contract, minus the purchase price of this option, up to a maximum of three thousand dollars (\$3,000) CAD.
- The request must be made by the consumer (signatory of the warranty contract). Any request made by another person will be refused, including the automobile dealer who sold the warranty contract or the financing company.
- The following items must be paid in full to the automobile dealer who sold the warranty contract or to the financing company to be eligible for premium reimbursement: the cost of the vehicle, the warranty contract, and all associated financial products.

- The request must be made in writing within thirty (30) days of the expiry date of the warranty contract or finance contract, whichever comes later, with the required documentation listed below:

- A copy of the original vehicle sale or lease contract;
- A copy of the original warranty contract, including all pages;
- A copy of the vehicle registration and proof of loan payment of the concerned vehicle.

- If there is no signature on the required documentation listed above, or if the signatures do not match or are not legible on all documents, there will be no eligible reimbursement.

- No claim must have been paid under the warranty contract during its term.

- There will be no reimbursement if the consumer has cancelled the warranty contract, transferred the vehicle to another person or if the vehicle has exceeded seventy-five percent (75%) of the authorized mileage, depending on the warranty term chosen.

31. * Additional option - Track Plus accessories: Starter, alternator, and air conditioning (A/C) compressor

32. * Additional option - Diesel exhaust fluid system (DEF): Nitrogen oxide (NOx) sensors, urea injector, diesel particulate filter (DPF), urea pump, urea tank, heating elements, urea line, soot particle sensor, and control unit.

33. * Additional option - Air bag suspension: Air compressor and block valve, provided no water is present inside the components.

34. * Additional option - Seals and gaskets: Front and rear main engine seals, cylinder head gaskets, intake manifold gaskets, front and rear transmission seals, pinion seals, and axle seals.
